In Fiscal Year 2022, more than 1,400 residents, family members, employees, businesses, foundations, churches, and friends made gifts to Phoebe.

Of all the numbers we report, the most inspiring number for me is the number of people and organizations who support our mission and ministry each year. I am thrilled to report the number of donors is growing. Each of you is a part of Phoebe's future, as donors of the past are a part of Phoebe today.

Pictured at right are myself and members of the Philanthropy team at the May 2022 Appreciation Event—the first one we've been able to have since 2019!—where we shared the following story:

John A. Beard was born in the 1860s. He was an attorney and President of Mifflinburg Bank, in Union County, Pennsylvania. Mr. Beard established a trust as part of his estate plan on October 11, 1945. He passed away on February 15, 1955, at which point Phoebe began to receive distributions from his trust.

His trust continues to provide income to Phoebe today—67 years after his passing. As Phoebe enters our 120th year, we continue to remember and honor Mr. Beard, and we are so very grateful for all that his estate plan has allowed us to do to advance our mission and care for our residents.

For me, this story is a powerful example of the lasting impact one person can have when they believe in the mission of an organization. Mr. Beard's gift was an act of faith in Phoebe's future. And 67 years later, we are still carrying out our mission and honoring the terms of his gift.

The Father of Monthly Giving

In December 2019, Phoebe's Office of Philanthropy got the type of rare phone call that warms the hearts of fundraisers everywhere. New Phoebe Berks resident Kevin Bitz called to inquire about becoming a monthly donor. Since then, Kevin's generosity has started a bit of a trend—one that Phoebe hopes will continue. To date, 12 more residents and family members have committed to making monthly gifts.

Kevin retired from Spring Township's Wastewater Treatment Plant in January 2020, about five months after he and his wife, Barbara, moved to Phoebe Berks. Barbara, who retired from the Wilson School District in 2012, was diagnosed with Parkinson's Disease in 2013.

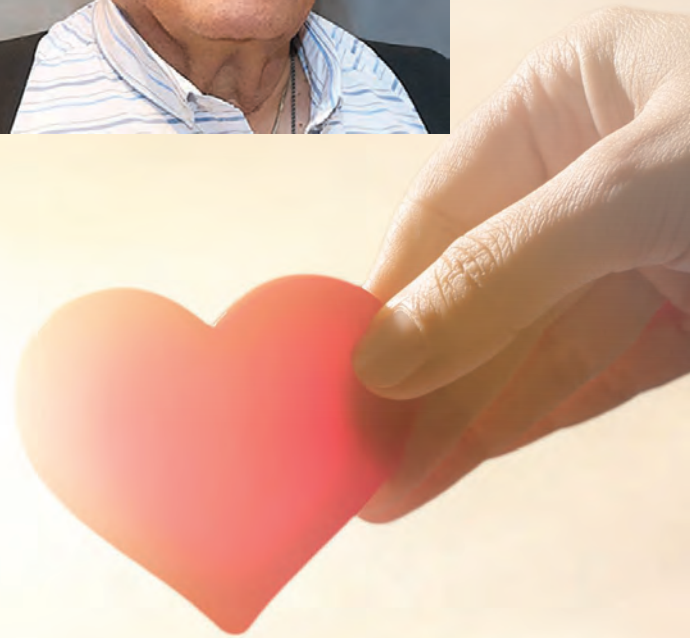
Barbara's diagnosis is what prompted the couple to consider a continuing care retirement community (CCRC). Barbara passed away in July 2022, shortly after the couple celebrated their 52nd wedding anniversary. She was an active member of St. John's Reformed Church in Sinking Spring and served as a Deacon, Elder, and member of the senior choir.

Kevin is grateful for the care that Barbara received before she died. His monthly contributions are split between Phoebe Berks and the Chapel Fund.

"We are so grateful for Kevin's initial inquiry into monthly giving," says Stacey Prohaska, Executive Director of Philanthropy. "Now, we fondly refer to him as the 'Father of Monthly Giving.'"

Kevin seems bemused by the title, but takes it in stride. "It's important to give back and take care of the organizations that take care of you," he says. "You owe it to them to participate." 🙏

EMPLOYEE GIVING

Phoebe employees take great satisfaction in providing personalized care services to our seniors. Their quality work and compassion for our residents have helped make Phoebe a leader in our industry for nearly 120 years.

We are grateful for our dedicated colleagues and those employees who take their commitment to Phoebe a step further by making leadership gifts, participating in our payroll deduction program, and supporting our annual Employee Campaign.

In 2022, 81 employees gave \$2,365 to the annual Employee Campaign to support wish items that our residents requested to enhance or offer new Community Life activities at each campus.

At Phoebe Allentown, campaign supporters provided a much-needed facelift for the gazebo (pictured above), a popular destination for residents to enjoy the outdoors and visit with family and friends. After many years of wear and tear, the gazebo received a fresh coat of paint and new furniture.

Residents of the Phoebe Berks Health Care Center received a new karaoke machine and an electronic dart board, and the game room at Village Commons Personal Care now features a multi-game table for billiards, foosball, slide hockey, and table tennis.

Phoebe Richland Health Care Center and Meadow Glen Personal Care each received a Cricut Explore



Air II cutting machine for residents to create a variety of art projects, including cards for holidays and special occasions.

Seven interactive robotic therapy pets, including three cats and four dogs, also made their way to residents at Phoebe Wyncote. These adorable companions help reduce stress and anxiety and promote mental stimulation for seniors with dementia.

In addition to monetary contributions, over 30 employees from all four Phoebe campuses and Phoebe Services help make the annual Phoebe Golf Tournament at Saucon Valley Country Club a memorable experience for more than 200 participants. Staff donate their time



to coordinate event registration, distribute gift items, and monitor contest games on three separate courses. We greatly appreciate their efforts and support of this important event that raises funds to help provide Charitable Care for our residents in need. 🍀

In 2022, the Century Circle included 170 donors who contributed over \$802,600 to Phoebe in support of personalized care, recreational and spiritual programs, special initiatives, capital improvements, and educational programs that advance our tradition of excellence as a senior care provider.

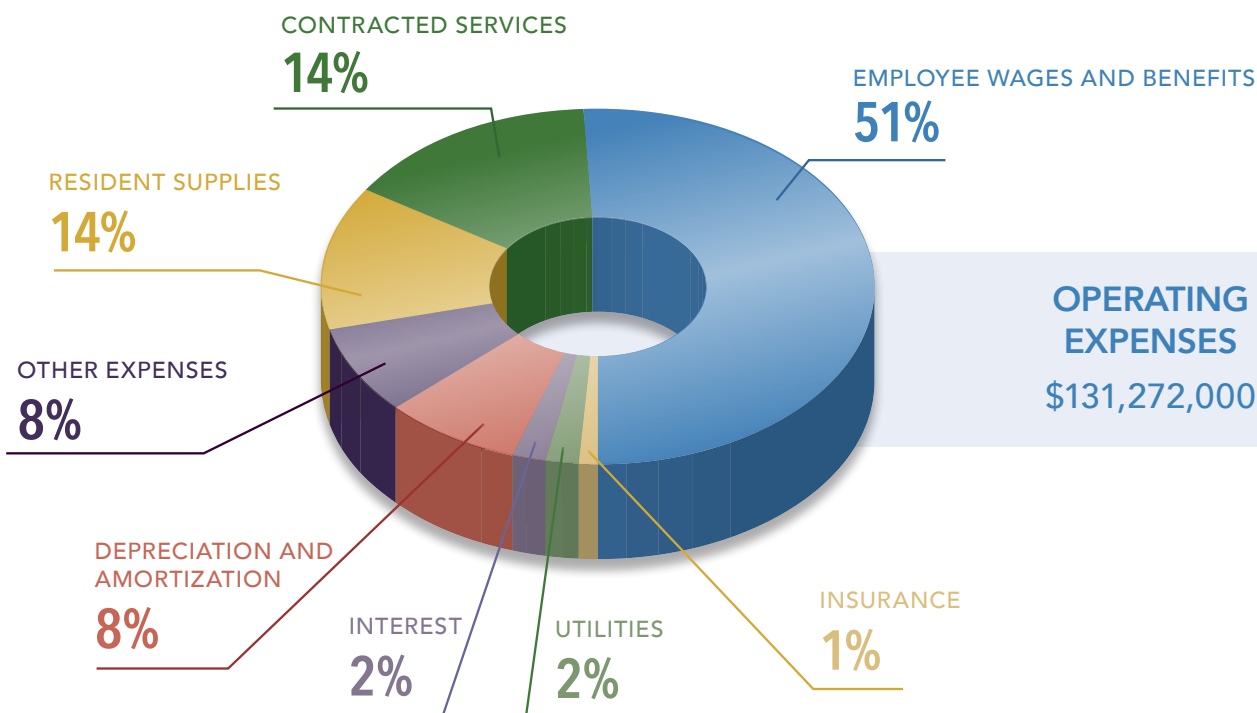
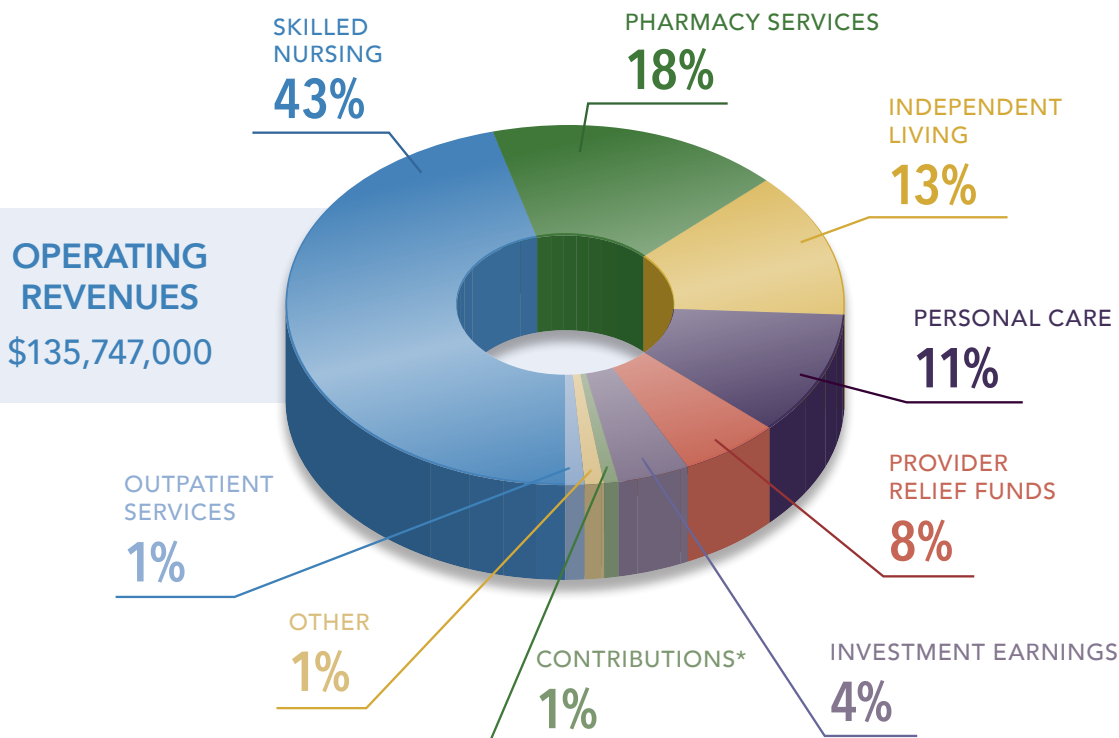

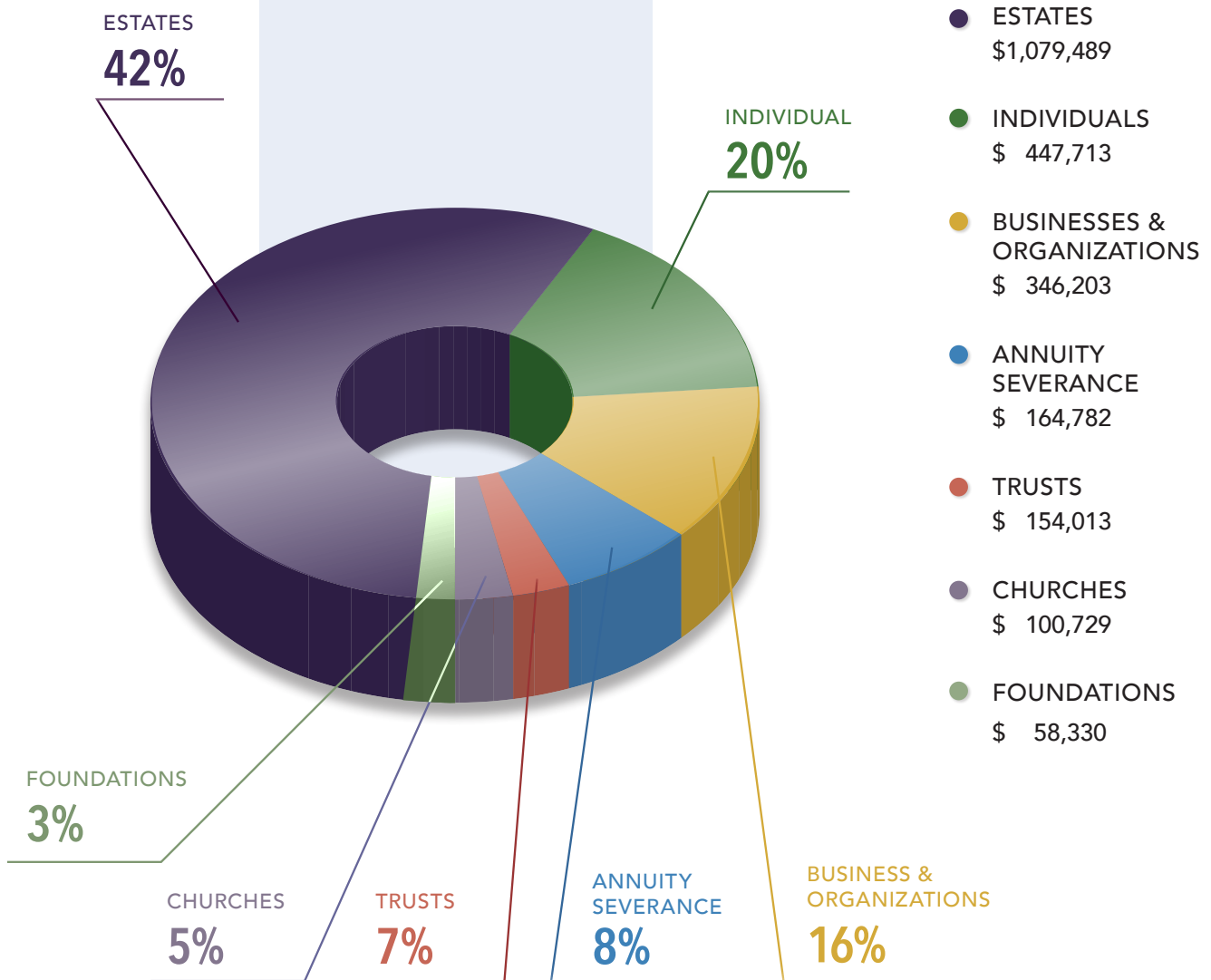
